#### Introductions

#### Special Guest, Pam Davenport, NLS Senior Network Consultant:

LeAnn introducing Dylan, new TBS CSR. LeAnn introducing Pam Davenport, NLS Senior Network Consultant and inviting her to share NLS updates.

**National Library Service Updates and Q&A time with Pam:** Pam let us know that she is planning on rescheduling her earlier planned visit to Boise. She shared our yearly work plan with other folks at NLS, they are excited about the plan and have some follow up questions for LeAnn.

NLS has officially announced that they are moving D.C. offices to the Adams building – the oldest building on the Library of Congress campus!

The National NLS conference will be in DC on Sept. 10-12. There will be a virtual as well as inperson components.

The next NLS virtual orientation will be in October.

Pam plugged the Many Faces of Bard and Braille E-readers – both are popular with users and an important resource. Stressing the importance of Braille literacy – for some folks with blindness, that is their central link to literacy. NLS has expanded E-Reader program, and they can be used with other personal devices. Technical questions can be directed to <a href="mailto:pes@loc.gov.">pes@loc.gov.</a>
Discussing smart speaker pilot – inviting us to be involved.

BARD 2: Enhancement to BARD is coming soon and will be rolled out to patrons first. We can still perform all necessary admin functions on BARD 1. New features include robust search engine and ability for advanced searching, patrons will be able to search recently added, popular downloads, and will be able to refine searches by format, language, and subject. Wishlists, reading history, subscriptions, and account settings will be under one menu. Patrons will have the opportunity to disable reading history. Download syncing between devices will also be enabled. Testing has been positive and NLS is excited to roll out.

Question from Lynn: Do we have marketing materials for the E-Readers? Answer: Yes, NLS has some varied materials that Pam will send to us

Question from Stephanie: When will the DA2's be in service?

Answer: They are still beta-testing, but the hope is that they will be deployed beginning in early 2025.

Question from Stephanie: Any upcoming national marketing or promotions we can look forward to participating in?

Answer: Pam doesn't have direct oversight on that, but she will pass that along to outreach team.

**TBS 2024 Work Plan:** LeAnn introduced Work Plan, highlighting plan to upload 12 locally produced titles, participate again in Summer Reading Program, updated TBS customer satisfaction survey, mailing list to targeted residents, and annual outreach target 24 in 24 – 24 care facilities in 2024. We are on track to roll out new logo and website.

Questions from Dana: What exclusions make books more accessible to users? Is there a way that we can send the info on the books listed on TBS calendar in a more accessible setting? Utah has a Braille calendar – could that be an option?

**TBS Summer Reading 2024:** The theme for this year is "Adventure Begins at Your Library". Relying partly on NLS programming for summer reading – Kickoff event June 24th, event scheduled for July 18<sup>th</sup>, and an author talk with Angeline Boulley. All patrons are invited to participate. Possibility of getting the word out to schools.

## **TBS Updates**

**Survey 2024**: Survey will be going out in spring TBS newsletter, available via a link online, and folks can also call in and complete with the help of a TBS rep. Open between May 1<sup>st</sup>-June 14th

**Outreach 2024:** Annual outreach target: 24 in 24 – 24 facilities in 2024. We sent out flyers and called on facilities. We are working on expanding efforts but having some issues with connecting with folks. Lynn expressed that they are having similar issues – facilities directors seem reticent to accept outreach efforts. Possibility of partnering with bookmobile efforts to allow for more widespread reach. Continue to partner with local libraries on care facility visits and ensure facilities know that the library is a local resource and liaison to our services. Dana offered some insight: Staffing shortages compounded by COVID at many of these places put strain on existing staff. They may view outreach efforts as "just another task".

**Term Expirations: Alison Steven –** Alison is previously retired, but will be contracting with ICBVI. She would like to be considered for an extension of her term.
